HOW MUCH DOES A POLAR BEAR WEIGH?

As a recent addition to the QA team, my only experience previously with QA was when I was working as a Report Writer. In my role, my work was subject to periodic QA audits. These are phrases that I would hear on a regular basis, and sometimes, much to my chagrin, I would utter myself:

"Why does QA make us do this?"
"There's no way QA will let us do that."
"You better just do it, or QA will write you up."

Simply put, I was part of the employee population that believed QA is a department to be feared, who lay down the law and expect to be adhered to strictly, no questions asked, like some sort of robot sent from a dystopian future to eliminate all irregularities.

Fast forward to my current status in QA, where my primary responsibility is auditing, I am faced with a whole new perspective.

When I walk into a room to perform an audit, I can feel the temperature in the room drop 20 degrees - *celsius*. I can see employees stiffen up, and I can hear the negative tone in their phrases, "Great, QA is here." This isn't always the case; there are times when auditees are just as comfortable with me being there as if I was just another member of their department. But the former situation, the cold reception towards members of QA, happens often enough that I've come to recognize it, and have wondered what I can personally do to change it.

As a result of the reception to QA audits, I broke this down to two key issues that I wanted to address: the lack of communication between auditees and QA; and confusion surrounding responses necessary to close out the audit findings. During my annual review, I discussed these issues with my manager who gave me a single piece of advice. She stated, "Try talking to new hires and introducing yourself as a person. Let them know that you aren't there to point out their mistakes, but make sure that they are prepared for any regulatory or client visit. You're there to make sure they are receiving the proper training and are as knowledgeable as they can be in their everyday duties."

With that simple, yet profound advice, I had a whole new perspective of my value to the team. To put the advice into practice, I implemented a few changes to my auditing style.

- A warm introduction for new employees during training and prior to each audit
- Engagement the departments that I may be auditing to ask questions and show a willingness to understand and accept their perspective
- During audits, reiterate to auditees that QA is a support department and available outside of audits

I approached these changes hopeful that these small measures will help employees understand that the QA department is made up of human beings, not T-800 Terminators, who are capable of making mistakes, and are a resource to help with any challenges, not reprimand for minor mistakes.

I have already started to see a change in the frequency of questions from the auditees prior to the audit and a genuine understanding and concern when findings are issued. I think they may have also raised the thermostat a few degrees for me...enough to break the ice.


